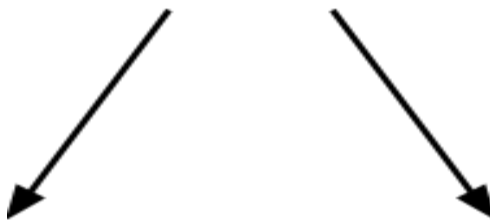


2018-2019 POWERSCHOOL REGISTRATION INFORMATION

ALL STUDENTS

PowerSchool Registration Process: (Deadline - 11:59 p.m. on July 31.)

- Go to the PowerSchool website (PowerSchool registration instructions are included in this mailing).
 - To apply for a fee waiver, your application must be submitted and approved **before** beginning the PowerSchool Registration process.
 - Questions regarding the fee waiver process should be directed to the Associate Principal's office.

Instructional Materials Pickup (Freshmen and Transfer Students Only)

- **August 6 - C101**
 - **8:00 a.m. to 11:30 a.m.**
 - **1:00 p.m. to 4:00 p.m.**
 - **5:30 p.m. to 8:00 p.m.**
- At Instructional Materials Pickup, there will also be a station for purchasing a Ventra card for those interested in using Pace transportation.

Important notes:

- If you do not complete the PowerSchool Registration process by 11:59 p.m., Tuesday, July 31, there will be a \$25.00 late fee applied to your student account, including those eligible for fee waiver.
- All non-digital instructional materials are property of District 207 and must be returned at the end of the school year to avoid additional charges.
- The bookstore will be closed the week of August 6.
- Ventra cards for returning students can be updated in the bookstore during normal bookstore hours through the summer.

For your convenience a computer kiosk will be available for PowerSchool Registration in the Main office Monday thru Thursday, 8:00 a.m. to 3:30 p.m. **(closed daily 12:00 - 1:00 p.m.)**
