Dear Parents and Friends,

The Maine South Music Booster Organization is parent run and a wonderful way to support the music programs at Maine South. Through Boosters, the students in Orchestra, Choir, Band, Piano, and Guitar are eligible to apply for scholarships for private lessons, summer camps, and college. During the 2018-2019 school year, Boosters provided \$13,500 for over 1,000 private music lessons, \$7,600 towards 16 Senior Scholarships, and awarded eleven Summer Camp Scholarships totaling over \$2,000.

Boosters also provide financial and hands-on help with concerts, equipment, guest musician clinics, travel experiences, snacks/meals, uniforms, etc., and respond to various requests from teachers throughout the year. In 2018-19, the Music Boosters were able to provide \$2,000 to supplement unexpected instrument repair and are on course to purchase additional instruments and accessories prior to the start of school. All of this would not be possible without the generous contributions from our Booster members.
