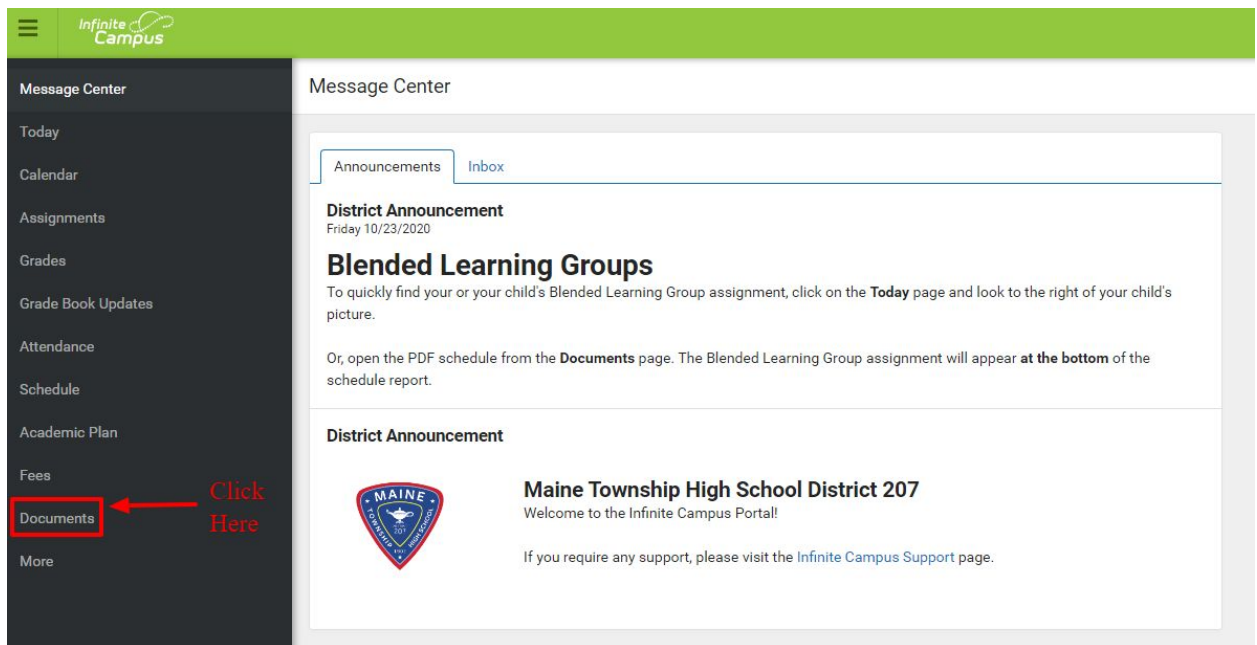
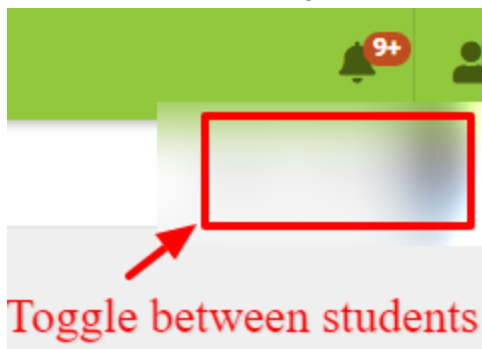


Instructions - Parent/Guardian Lunch Release Consent Agreement

as described in the preceding sentence. As used in this paragraph, the term claim includes, but is
not limited to, the attorneys' fees and expenses and any monetary loss or damages incurred by
the School District in settlement and/or litigation of any claim and in the enforcement of the
foregoing commitment. Also as used in this paragraph, the term School District includes Maine
Township High School District 207, its Board of Education and the Board of Education's
members, employees and agents in their official and individual capacities.
